2. Coverage

These are the general terms and conditions of trade for BRIGADE MUSIC and their clients. The current version at the time of ordering will be the valid version at all times. No other conditions will be accepted by BRIGADE MUSIC, unless BRIGADE MUSIC has given explicit permission in writing for each separate incident.

3. Offers

The goods displayed on our online presence are without obligation. A sales contract comes into being only after the order confirmation by BRIGADE MUSIC.
The acceptance of the order is conditional the legal allowance of the material and also of the availability of the ordered goods. When BRIGADE MUSIC cannot accept the client's offer, the client shall be informed of this unavailability. Any services already rendered by the client shall be refunded immediately.

4. Price

There will be an additional charge for shipping costs and packaging, as mentioned on the website or a variable charge communicated in another way.

5. Shipping

If not specified otherwise, the delivery will take place immediately after receipt of payment to the address which the client notes at the submission of the order. BRIGADE MUSIC will deliver the goods under the conditions agreed with the client.

Payment options

BRIGADE MUSIC accepts only the payment options that are made known during the placing of the order (Pay-Pal or bank transfer with pre-payment).

6. Retention of title

BRIGADE MUSIC remains the legal proprietor of the delivered merchandise until full payment is made.

7. Cancellation

The client can cancel his purchase within two weeks in written form (letter or e-mail) or by returning the goods (shrink-wrapped), without giving reason for doing so. The period begins at receipt of the goods, and not before receiving this stipulation. The cancellation is considered punctual when the cancellation or the merchandise is sent in time. At the return consignment of (part of) the merchandise within 14 days, in case the total value of the order is no more than 40 Euros, the client will bear the cost of delivery, if the merchandise was delivered correctly as ordered.
